※ Note

1. Because incorrect information in the application can lead to [complications](#) for the applicant (inability to process any changes, inability to receive election information, etc.), please fill in all information legibly and accurately.
2. Those who have falsely applied for changes of information cannot participate in voting and may be punished (up to 3 years of imprisonment or a [fine of up to 5 million Korean Won](#)) in accordance with Article 247 of the "Public Official Election Act."

※ Tips

1. In the **"Personal Information"** field, please enter the current personal information of the applicant.
2. In the **"Name"** field, you must accurately enter the name as shown on the family relation register (family register).
3. In the **"Canceled Korean Resident Registration Number"** field, a canceled [Korean](#) resident registration number must be entered for a person who had a resident registration number [in Korea](#), and the date of birth and gender must be entered by persons who have never had a resident registration number [in Korea](#).
4. In the **"Names of Parents"** field, those who never had resident registration number in Korea must enter the "Father's Name or Mother's Name" shown in the family relation register (family register) in order for the accurate confirmation of citizenship/identification and place of family registration (address of the original domicile).
5. In the **"Final Address in Korea"** field, the "Final Address in Republic of Korea" must be entered for people who had a resident registration number [in Korea](#). For people who never had a [Korean](#) resident registration number, the **"Place of Registration (Origin of Domicile)"** shown in the family relation register (family register) must be written.
6. In the **"Overseas Address"** field, the location where you can receive mail from the residing country must be entered using the Roman alphabet or English in [block capitals](#) (local language can be used additionally), and e-mail address and phone numbers (country code - area code - phone number) such as [home, office or cell phone number](#) must be written in the **'overseas address' field** to enable contact from the residing country.
 You must fill in the overseas address, e-mail address, and phone number accurately because they are used to provide various election-related information/material such as political party/candidate information [prepared and sent](#) by the National Election Commission, notification of voter list registration, guide to appeal application, and voting time/location/requirements.
7. In the **"Changed Items"** field, enter the information that is being changed such as name, passport number, canceled resident registration number (date of birth/gender), final address in Korea (place of registration), and overseas address (e-mail address, phone number).
8. In the **"Reporter"** field at the end, you must write your name and sign or seal.
